98 Holdings is a subsidiary of Excel Partners Pte. Ltd. ("Excel Partners"). Each of Y.S. Fu Holdings (2002) Pte. Ltd. ("Y.S. Fu Holdings"), Excelfin Pte Ltd ("Excelfin") and Reef Investments Pte Ltd ("Reef Investments") is a shareholder of Excel Partners holding 20% or more of the equity interest in Excel Partners. Reef Holdings Pte Ltd ("Reef Holdings") holds more than 50% of the equity interest in Reef Investments. Mr. Ong Beng Seng ("OBS") holds more than 50% of the equity interest in Reef Holdings.
